<b>Purpose</b>	The purpose of this policy is to ensure a coherent and consistent approach towards supporting and educating students' about personal relationships and what is and isn't acceptable within different relationships. It seeks to ensure a proper balance between an individual's rights and responsibilities, their physical and emotional safety, and the rights and responsibilities of others.
<b>Scope</b>	This policy applies to all staff

<b>Definition(s)</b>	<p>Within this policy the word 'student' will be used to describe all of the groups that attend Derwen College, this includes residential students, day students, short breaks guests and clients.</p> <p>Within this policy the words "sexual relationship" and "sexuality" are intended to include heterosexual, gay, lesbian, bisexual, transsexual and transgender relationships.</p>

## **Personal Relationships Policy**

### **1. Policy Statement**

Derwen College recognises that personal and intimate relationships, including sexual expression, are an important aspect of life and identity. All students have the right to enjoy safe, healthy, respectful, and consensual relationships. The college is committed to promoting these rights while ensuring safeguarding, dignity, and wellbeing are central to all support offered.

This policy applies to all students and staff across the college, including satellite sites and residences.

### **2. Principles and Rights**

Derwen College promotes the right of all students to:

- Experience loving, consenting relationships (sexual or non-sexual).
- Receive education and information about bodies, consent, relationships, and sexual health, tailored to individual need.
- Develop relationships that are legal, safe, and respectful.
- Be protected from abuse, exploitation, or coercion.
- Express their sexual identity and orientation without discrimination.
- Choose whether or not to have a sexual relationship.
- Access support and advocacy where needed to navigate relationships.

### **3. Education and Information**

Relationships and Sex Education (RSE) is a statutory requirement up to age 16, as per the **Education Act 1996** and **DfE Statutory Guidance (2019)**. For students aged 16+, Derwen College continues to provide RSE and Health Education as good practice, ensuring:

- Age-appropriate and accessible resources.

- Sessions tailored to individual learning needs, communication styles, and cognitive levels.
- Opportunities for both group-based and 1:1 learning.
- Open, inclusive discussions about sexuality, relationships, gender identity, and consent.

Where needed, students are supported to explore topics with key workers, the nursing team, or external agencies.

#### **4. Consent and Capacity**

Capacity to consent to relationships and sexual activity is assessed in line with the **Mental Capacity Act 2005** and the college's internal **Mental Capacity and Decision-Making Procedure**. Staff:

- Presume capacity unless proven otherwise.
- Support students with information, resources, and accessible communication methods to help them understand decisions.
- Involve families or external professionals (e.g. social workers) when required and with the student's permission.
- Seek safeguarding and legal advice where there are concerns about capacity or exploitation.

#### **5. Privacy, Space, and Boundaries**

Students have the right to privacy in their relationships. Derwen College supports students to:

- Access each other's accommodation for social or romantic visits, where capacity and consent are clear.
- Make decisions about their own bodies and behaviours in private spaces.
- Access contraception and sexual health services confidentially.
- Express affection appropriately in line with public/private behaviour guidance.

**Note:** Overnight stays in another student's room are not permitted for reasons of health, safety, and fire compliance unless a specific agreement is in place ahead of time.

Staff will support students by:

- Facilitating private space where appropriate.
- Helping students access condoms and contraception.
- Discussing what is appropriate in public vs private settings.
- Offering guidance on respectful, safe, and lawful relationship behaviours.

#### **6. Safeguarding and Reporting Concerns**

All staff must be vigilant to signs of:

- Coercion, exploitation, grooming, or abuse.
- Unhealthy or unsafe relationships (including peer-to-peer abuse).
- Students engaging in sexual activity without sufficient understanding or capacity.

Any concerns must be reported immediately to the **Safeguarding Team**, following the college's **Safeguarding Policy**. In cases of immediate risk, the police or relevant authorities must be contacted without delay.

## **7. Confidentiality**

Students have a right to confidential advice and support. However, confidentiality will be broken if:

- There is a risk of harm to the student or another individual.
- The student lacks capacity to make a safe decision.
- There is suspected abuse, exploitation, or criminal activity.

Where information must be shared, students will be kept informed and involved wherever possible.

## **8. Staff Conduct and Professional Boundaries**

Staff must:

- Maintain clear professional boundaries.
- Avoid expressing personal beliefs in ways that influence or restrict student rights.
- Respond to students' questions or behaviours with sensitivity and factual information.
- Seek supervision and guidance where they are unsure or uncomfortable.

Managers must ensure that staff are confident and competent in implementing this policy, and that training and supervision are regularly reviewed.

## **9. Touch and Affection**

Students are supported to understand:

- What kinds of touch are appropriate in different settings and relationships.
- That touch can be misinterpreted or misunderstood.
- How to express or decline affection safely and respectfully.

Staff must also set clear boundaries around physical contact, modelling appropriate behaviour at all times.
